## Executive Director Report by Joanne Shannon

Common Weal Community Arts continued on a steady forward pace this year, having built a strong organizational foundation and keeping constant with a hard working creative staff and a dedicated board. Mirtha Rivera led the board this year as chairperson with few changes to the leadership. I am very grateful to the board for their input and support over the past year. The staff remained the same, with Judy Mc-Naughton as Northern Artistic Director, Gerry Ruecker and Southern Artistic Director, Terri-Lynn McDonald as northern office support and Leah Mazur as our communications person, working out of the Southern Office. This staff brings experience and organizational skills and creativity to the organization. The Artistic Directors are key to the projects and programs that we undertake at Common Weal and their vision is the heart and soul of the work that we do with communities. As I was faced with health problems this year, it was especially important to have such a supportive team to move the organization forward.

We also could not carry out our programs and projects without the support of our funders. The Canada Council and the Saskatchewan Arts Board provide core operational funding as well as support for projects. We are also pleased to have received project support from the Multicultural Council of Saskatchewan, SaskCulture, the Community Initiatives Fund, SaskLotteries, City of Regina, City of Prince Albert, and the Government of Canada. In addition, Common Weal was successful in receiving support for programming next year from ArtsVest which

matched a grant from Conexus Credit Union. Sponsorships were also received from Great West Life and SaskEnergy. Almost \$30,000 in additional sponsorships were granted to Common Weal this year which will allow the SSILC project to continue with Traci Foster for an additional year.

I was also very pleased to be granted a personal travel grant from Canada Council. With the support of the professional development budget from Common Weal, I was able to travel to the World Summit for the Arts in Melbourne, Australia. There, I met with individuals and groups from all over the world that are involved in community arts. It was a great opportunity to share stories and learn about the work that others are doing around the globe. Similar support was given to Gerry Ruecker who was able to travel to London, England to undertake a course in how to conduct photo journalism courses with communities. This was also a very successful experience. Not only do we learn from others, but traveling to other centres, helps others learn about the work that we are doing in Saskatchewan.

Connecting with the public and becoming better known in the communities where we work was one of the goals of Common Weal this year. We participated in the Cathedral Village Arts Festival, the Regina Folk Festival, and the Dunlop Art Galleries, Living Pictures. Common Weal also participates and supports the work of other organizations by attending events such as the Saskatchewan Arts Alliance Conference and the SaskCulture Conference and supports initiatives in the arts and social justice areas. We care about the challenges faced by the arts community and disadvantaged groups in Saskatchewan.

Common Weal has carried out many valuable and exciting projects and programs over the past year. We are pleased to have a new look, with the implementation of our new logo, designed by Leah Mazur. We launched the new logo and our History Book at an open house on June 13th. We have expanded our outreach to Northern Communities and held an excellent symposium that brought together many groups and individuals interested in Community Arts. These projects and others will be outlined in the reports of our Artistic Directors. Common Weal continues to be a stable, forward looking organization that all who are involved can be proud of. Thank you to all who have contributed in any way, large or small, to our success over the past year.






## Southern Artistic Director Report by Gerry Ruecker

Listen to Dis: Voice

2012 was the second year of this Sask Arts Board Creative Partnerships Program with SSILC (South Sask Independent Living Centre), utilizing voice, movement, and theatre techniques in an effort to give voice to members of the disabled community, and develop their theatre and performance abilities. Under the direction of Project Artist Traci Foster, participants have made incredible progress in their artistic and personal development as a direct result of the program. They have been creating and performing individual and group works. The first public performance was presented as part of Common Weal/SSILC's contribution to Culture Days, Sept 28- Oct 3, receiving a standing ovation. Since then, members of the Voice group have taken the initiative and independently begun seeking out and giving performances at numerous senior centers and daycares in Regina.

### **Community 4 Connection**

Common Weal participated in the first Community 4 Connection, a gathering focused on providing services and helpful information for individuals experiencing issues around homelessness. Common weal contributed to the event on two fronts: Leah Mazur, our intern, assisted with organizing the event, and we presented the installation 'Before I Die', in which participants and individuals were invited to share their hopes, dreams and wishes in this life.



### **Antipoverty Arts Festival**

This festival, much like the Community 4 Connection, was an attempt to inform and offer assistance to people facing circumstances of poverty in Regina. Common Weal participated in the Antipoverty Arts Festival with 'Before I Die' and a presentation of 'North Side Story or Two'.

### Lives in Focus

A year-long project in partnership with Street Culture Kidz and Sask Filmpool Co-op, working with ten young women, ages 15-18, who live in Street Culture group homes, due to poor home situations. The twopart program consists of 5 months of instruction in the art of photography under the direction of Gerry Ruecker, and 5 months of training in the art of video creation, with Leslie Farley. Kelly Ann Reiss coached participants in writing and journaling skills, which were then paired with the photographs and videos. The intent of the program is to provide an artistic means for these young women to give voice to their lives and circumstances, as well as offer awareness of alternative career options.






### State of the Art Symposium

A great day of meeting, networking, and sharing community art projects and practices involving over forty artists, professionals and interested individuals. Eight artists actively engaged in community related work, including Ruth Howard of Toronto's Jumblies Theatre, gave presentations on their work. As well, there was a performance by the Listen to Dis: Voice group. There was a noticeable joy experienced by all participants from the ability to meet and share with peers. State of the Arts was a prequel for the Arts For All Essentials workshop, scheduled in Regina in October 2012.

### Through Our Eyes Photobook Launch

Due to the success of the 2010 Through Our Eyes photo project; a partnership with Regina Open Door Society, in which ten newcomer youth were taught photography and journalism under the direction of Project Artist Gerry Ruecker, Common Weal produced a book documenting and celebrating the project. The book was very well received, with over 40 in attendance, including numerous participants of the family members, and interested community members.





### I want.... For my Neighbourhood

Common Weal participated in the 2012 Cathedral Village Arts Fair with this interactive art project, in which festival-goers were invited to write their desires for their neighborhood on 3"x4" stickers, with which to attach to their clothing, thus announcing their hopes. The intent of the installation was to offer an unmistakable opportunity for community members to voice their desires for their community.



#### The Future Tree

Our second annual collaboration with the Regina Folk Festival, again a very well received project. Under the direction of Project Artist, Dr. Rebecca Caines, of the University of Regina, the installation centred around exploring fears, anxieties and dreams for a future that includes technologies and bodies growing together. This installation was a tree shape constructed from old parts attached onto the dividing wall. Participants at the festival were invited to write their hopes, dreams, fears, visions for the future on individual leaves with markers and then attach them to the tree themselves.

### **Living Pictures**

Common Weal's first contribution to the Regina Public Library's Living Pictures event was a great success, with our installation based on the film 'Marwencol', about the highly unusual and unforget-table efforts of a mentally damaged individual's efforts at personal trauma therapy after his medical benefits had expired.

### Northern Artistic Director Report

The Shelter Project: Little Stories



In August and September 2011, the teen participants created ceramic sculptures exploring issues important to their lives, working under the mentorship of Saskatoon ceramic artist Carole Epp. In February and March 2012, writer Lynda Monahan met with a group of young mothers at the YWCA Rendalyn Home residence for a month-long journaling project. They created individual handmade books with Big River artist Jan Woods, in which they entered some of the writing pieces developed during their writing workshops. The Shelter Project: Little Stories was funded through SaskLotteries' Community Grant, and delivered in partnership with the Prince Albert YWCA. The participants were youth living in residence with the Prince Albert YWCA, through Program Coordinator Tammy Burns who has been a valued partner for a number of years.

### YWCA / Michèle Mackasey residency, Saskatoon

Saskatoon visual artist Michèle Mackasey has established a history of community involvement and a personal art practice that addresses issues of social justice, with particular interest in single parenthood and adequate housing. Her recent solo exhibition of local family portraits face à nous at the Mendel Art Gallery in Saskatoon garnered a great deal of attention.



Between January 15 and April 30, 2012 Common Weal received a Saskatchewan Arts Board, Partnership Exploration Grant to investigate the potential of an artist residency at the Saskatoon YWCA. Michèle Mackasey coordinated with staff at the Saskatoon YWCA, introducing workshops for women and youth in the shelter to help determine whether there is a need or desire for a resident artist in the facility.

Responses from staff and participants in the Partnership Exploration phase led to the conclusion that a resident artist would indeed be effective in the facility. Subsequently Common Weal received a Saskatchewan Arts Board, Partnership Innovations Grant to bring visual artist Michèle Mackasey as a resident artist into the Saskatoon YWCA beginning September 2012. The residency will engage single mothers and their families, through a lens of visual art, story telling and portraiture.

### The Pine Grove Creative Circles Program/ Prison Songs; why the caged bird sings

Common Weal has been working with Pine Grove Women's Correctional Centre for about 7 years. The Pine Grove Creative Circles Program originated in 2004, since that time the program has included artists of various disciplines. In 2008 and 2009 singer, songwriter and performance artist Cheryl L'Hirondelle spent a week with the women in an intensive songwriting experience, which produced collaboratively written songs, The Beauty Within and The Journey Home recorded with the women themselves singing

We have received funding through the Aboriginal Arts and Cultural Leadership grant (SaskCulture) to bring Cheryl and a music producer to Pine Grove in 2011/12 to do week-long songwriting intensives with a group of inmates taking part in the institution's Literacy Program. Each session results in a collaboratively written song that is professionally recorded. These songs will ultimately become part of a CD being produced as part of Prison Songs: why the caged bird sings, a collaborative songwriting and album creation project by Cheryl L'Hirondelle taking place in a number of correctional facilities in Canada. The songs that have been recorded so far are quite beautiful.

Common Weal hopes that by bringing a professional artist to help this highly marginalized group (incarcerated women) express their circumstances, hopes, fears and desires will allow these perspectives to be heard, perhaps effecting community perceptions.





#### Northern Artist Initiative in Patuanak and Area

This project provides the opportunity for members of the northern communities, particularly youth, to engage in individual and collaborative art making through a series of art camps and workshops with visual artist Michèle Mackasey. The program took place between January 2011 to July 2012 in the northern Saskatchewan communities of Patuanak, Beauval and at the Key Lake Road culture camp. The program was funded through Multicultural Initiative Fund and Community Initiative Fund.

### Lynda Monahan, Writing for your Life program

Prince Albert branch of the Canadian Mental Health Association requested a journaling project with writer Lynda Monahan. In this program, Lynda meets regularly with a writing group at The Nest, a drop-in center run by the Prince Albert branch of Canadian Mental Health Association. The participants learn journaling techniques, a manner of writing about their own life experiences in a way that is both a self-exploration and an avenue of sharing these experiences with their community and wider public. The participants have the opportunity to work with guest writers and artists throughout the program, and share their writing in publications, readings and public events. This project takes place between January 2012 and the spring of 2013. It is funded through the SaskLotteries Community Grant Program and the Community Initiative Fund.



### Artist in Residence Report

The second year of The SSILC Voice and Movement Project, made possible through a Saskatchewan Arts Board Partnership Innovations Grant, has just been completed. And what a year it has been! The relationship between Common Weal Community Arts, the South Saskatchewan Independent Living Center (SSILC), and myself, has blossomed into an inferno of artistic opportunity for everybody involved.


The most exciting artistic endeavor that has been founded this year is the performance collective known as 'Listen To Dis' Voice.' The group is made up of 12 of the regular participants from the weekly workshops I hold. Beginning in mid September, they will be rehearsing for 4 shows they will be performing this October. One of these shows is in Moose jaw - our first, and not our last, out of town gig! The performance - bits and Pieces of Dis' and dat' - is a montage of songs, poems and monologues performed by the collective.

The Project Kinesiologist, Tanya Gallagher, is still working her magic for the participants in the program. Week after week, she assesses the

participants needs - people with autism, in wheel chairs, vision impaired, fetal alcohol syndrome, cerebral palsy, MS, et cetera, to adapt the work, ensuring full inclusivity. We now know her as 'the Adaptor!'

This past year, we have hosted a number of artists through the 'Visiting Artist' series, most of whom are from Regina. In addition to the local artists, K.J. Holmes, a New York dancer, was here in June, working with the collective through contact improvisation and dance. In February, we sang our hearts out with Fides Krucker, Toronto based opera singer and teacher.

I had the great privilege to work with both visiting artists, KJ Holmes and Fides Krucker, while they were in Regina, for my ongoing research and development of: Dancing With the Shadow.



In conclusion, the Voice and Movement Artist in Residence Program has been a life changing experience, for me. I have witnessed, first hand, what the arts can do to combat isolation and promote inclusion. My work as a voice teacher has been forever changed by the people I have had the honor of working with in the past two yeas. The group and their willingness to break barriers and take risks continues to inspire me. It is with them that I will continue to advocate through the arts for equality, inclusion, and understanding of the disabled population. Until we no longer have a label, separating us from them, our work is not done. Helping people to find their voice, which enables them to speak on behalf of what they believe - think and feel - is and continues to be our collective goal.

Thank-you Maggie Dixon (SSILC) and Gerry Ruecker (Common Weal) for dreaming this project to life and believing we could make it happen! A special thanks to Joanne Shannon, Leah Mazur and the board for supporting this all the way to an additional year!

### Auditor Report

To the Board of Directors of Common Weal Community Arts Inc

I have audited the a ccompanying financial statements of the Common Weal Community Arts Inc, which comprise the Statement of Financial Position as at August 31, 2012 and the statements of Operations and of Cash Flows for the year then ended, and a summary of significant accounting policies and other explanatory information

Management's Responsibility for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with Canadian generally accepted accounting pri nci ples and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Auditor's Responsibility

My responsibility is to express an opinion on these financial statements based on my audit. I conducted my audit in accordance with Canadian generally accepted auditing standards. Those standards require that I comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risk of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

I believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for my opinion.

#### Status and Objectives of the Organization

Common Weal Community Arts Inc. Is incorporated pursuant to the provisions of the Non-Profit Corporations Act of Saskatchewan and is a registered charitable organization. The corporation is involved in developing and co-producing participating community arts projects. In July, 1997, Common Weal's mandate expanded to include all arts disciplines. Prior to that date Common Weal produced theatre projects involving community people and theatre professionals.

Currently, the provisions of the *Income Tax Act* exempt the net income of these corporations from taxation. Accordingly, there is no provision for income tax included in these financial statements.

#### Significant Accounting Policies.

These financial statements are prepared in accordance with generally accepted accounting principles for nonprofit organizations. The following policies are considered significant.

#### Fund Accounting

These financial statements are prepared using fund accounting and include the following funds:

Operations - The operations fund reflects the organization's core revenue and expenses and operations.

Capital Assets - The capital asset fund reflects the organization's net assets invested in capital assets.

**Project Fund** - A fund has been internally restricted to reflect the results of operating various projects from year to year. Any unused surplus of a continuing project is deferred to the subsequent year in order to match the expenditure of those funds. In accordance with the particular project funding agreement, upon completion of a project, funds are either returned to the contributor or transferred to the operating fund.

#### Revenue Recognition

Common Weal follows the deferral method of accounting for contributions. Restricted contributions are recognized as revenue in the year in which the related expenses are incurred. Unrestricted contributions are recognized as revenue when received or receivable if Common Weal can reasonably estimate the amount of the future contribution and collection is reasonably assured.

#### Capit al Assets

Capital assets are stated at cost less accumulated amortization. Amortization is calculated using the diminishing balance method at rates established to charge the cost of the asset to operations over the estimated useful life of the particular asset. In the year of acquisition. Amortization is limited to ½ of the amortization amount calculated using the amortization rate for the applicable asset category. Amortization is calculated using the following rates:

Equipment	20 %

#### Measurement Uncertainty

The preparation of financial statements in accordance with Canadian generally accepted accounting principles requires management to make estimates and assumptions. These estimates and assumptions may affect the reported amount of financial assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the reporting period. These estimates are reviewed periodically, and as adjustments become necessary, the adjustments are reported in earnings in the period in which they become known.

#### Financial Instruments

Common Weal's financial instruments consist of cash, investments, accounts receivable, accounts payable and accrued liabilities. It is management's opinion that Common Weal is not exposed to significant interest, currency or credit risks arising from these financial instruments

#### Investments

Securities which Common Weal both positively intends and has the ability to hold to maturity are classified as investments held to maturity and are carried at amortized cost. Intent and ability to hold are considered to be satisfied if an investment is available to be sold in response to changes in interest rates, prepayment rates, liquidity needs or other reasons as part of the overall asset management strategy.

Accounts Receivable and Accounts Payable

Accounts receivable and accounts payable include financial instruments categorized as loans and receivables and are reported at amortized cost.

Interest Rate and Market Risk

Due to the nature of the investments held, the Organization's portfolio contains minimal risk associated with interest rate and market fluctuations.

Credit Risk

The Organization does not have significant credit exposure to any individual customer or counterpart.

#### Capital Assets


